1	23-07-2024	Regarding LOT 2 - Low Platform Trailer, which requires a license plate, who will be responsible for obtaining the plate number?	The Buyer, DRC Ukraine, will assume responsibility for registering the trailer and obtaining the required license plate. The Supplier is required to furnish a complete set of registration documents, encompassing the certificate of conformity, customs documentation (if necessary for import), payment of customs duties, and the technical passport. Furthermore, the Supplier is responsible for delivering these trailers to the Buyer. Typically, transportation involves loading them onto a car carrier, truck, railway platform, or similar means, as the trailers do not usually move under their own power.
2	26-07-2024	The specification includes a Preferred Option: GPS Programmable for Remote-controlled undergrowth cutting machine. Since this option is preferred rather than mandatory, would an offer without this option still be considered compliant?	Since the GPS Programmable option is preferred, the offer will still be considered compliant.
3	26-07-2024	According to the tender instructions, given that DAP and DDP Incoterms are accepted, is it accurate to state that under DAP, the Supplier assumes responsibility for managing the export procedure, while the DRC manage the import procedure?	Under the DAP Incoterms, the Supplier will be responsible for overseeing the export procedure, while the DRC will be tasked with managing the import procedure. It is important to note that the cargo will be delivered to Ukraine as humanitarian aid, and the DRC will furnish all essential customs documentation required for this delivery to Ukraine.
4	26-07-2024	As per the tender instructions, although the supplier anticipates sending the Remote-controlled undergrowth cutting machine without any prepayment, is it permissible to request a bank guarantee as the payment terms for the contract?	The payment terms involving a bank guarantee will be subject to additional negotiation during the contract negotiation stage with the awarded supplier. It should be noted that DRC will not incur any costs in the event that a bank guarantee is agreed upon, and the supplier will be responsible for any associated costs.
