




## Responding to unprecedented needs

The ongoing war in Ukraine has profoundly impacted millions, with 12.7 million people—over a third of the population—expected to need urgent assistance in 2025. Civilians across the country face immense challenges, particularly in the east, south, and north.

Escalating violence has displaced families and deepened vulnerabilities, while attacks on infrastructure threaten millions with extreme winter conditions. Amid this crisis, the Danish Refugee Council remains committed to alleviating suffering, restoring dignity, and offering hope in collaboration with national and international partners.

## **Partnering with local CSOs**

To ensure timely and comprehensive assistance across Ukraine, DRC collaborated with 34 civil society organisations (CSOs), delivering support to over 22,100 individuals through the Emergency response programme, Protection, Economic recovery, Shelter and settlements, and Humanitarian disarmament and peacebuilding sectors.



## **Advocating for rights and services**

DRC continues to advocate for better access to rights and services for conflict-affected communities while promoting a principled, timely, and accountable humanitarian response.



## **Supporting long-term solutions**

We support long-term solutions to help displaced individuals regain stability, access essential services, and rebuild their lives. DRC is committed to strengthening national legal frameworks to protect the rights of internally displaced people (IDPs) and others affected by the conflict, while fostering a supportive environment for humanitarian efforts.



## **Empowering first responders and local initiatives**

We also call for flexible funding to empower first responders and local initiatives, aiming to mitigate the conflict's impact and support sustainable recovery.

## Collaborating for practical solutions

Through our advocacy programme, DRC works with key stakeholders, including the Ukrainian government, UN agencies, and the international community, to highlight the needs of conflict-affected communities and develop practical, lasting solutions.

## Data-based approach to address challenges

We take a comprehensive approach, using research and realtime insights from our work across the country, such as protection monitoring, legal support, and community engagement, to guide our advocacy. ## **Partnering with local CSOs**

In northern Ukraine, DRC partnered with the Chernihiv Public Committee for Human Rights Protection, the League of Modern Women, FRIDA, the Ukrainian Coalition for Legal Aid, Renaissance of the Nation, the Public Sumy Circle, and the Innovative Social Solutions and Lampa, providing Protection and Emergency response assistance to 8,674 individuals.



"I understand there are risks in this job. However, I work with confidence because I have been properly trained and know the safety rules. I also trust my colleagues," says Victoriia, a DRC deminer.

Victoriia has been working with the Danish Refugee Council for over a year. Before that, she was a salesperson in a store in Luhansk Oblast. She applied for a vacancy, underwent training, and began clearing areas of explosive ordnance.

"I am motivated by the fact that we are doing something good for people. The more we clear, the fewer risks there will be. Secondly, there's the socio-economic impact—I know this work is important for communities, and it's important to me as well," she adds.


## Pravovsim.org — digital legal aid platform

"Many people who have fled their homes because of the war are now internally displaced and in need of help, including legal assistance. We assist with issues such as inheritance registration, compensation for destroyed or damaged housing, and document recovery.

For example, restoring one woman's passport allowed her to receive aid from a humanitarian organisation, enabling her to buy firewood and survive the winter in warmth. Or when someone finally receives compensation to rebuild their home, it motivates me to keep helping others," says Vitalii, Protection Officer (Lawyer) at DRC.
